








Simplified Results Framework

Output indicator	Actual Dec 2016	Target Dec 2018
Number of people participated in trainings & workshops in targeted fields	957	500
Number of participants report that training was useful (%)	94.83%	80%
Number of participants report improved skills (%)	82.91%	70%



Data measured October 2016- December 2016:

- 94.83% of people satisfied (partially and fully) with the usefulness of the seminar for their daily work (14.83% above requested 80%)
- 82.91% of people satisfied with the extent that training had improved their skills (12.91% higher than requested 70%)

571 users trained (of total 957 in 2017)
