The World Bank implementation support mission for the Multi-Donor Trust Fund for Justice Sector Support (MDTF-JSS) project visited Serbia from September 16 to 30, 2016. The World Bank team was led by Ms. Georgia Harley (Justice Reform Specialist and Task Team Leader) and comprised the following experts: Ms. Nicole Ridley (Court Registry Expert), Mr. Srdjan Svirčev (Public Sector Specialist), Ms. Marina Matić (Justice Reform Expert), Mr. Nenad Milić (Communications and Online Transparency Consultant), and Ms. Bisera Nurković (Program Assistant).

The objectives of the mission were to:

- a. monitor the implementation of ongoing activities (analyses of non-core functions in the judiciary, victims support, prosecution budget planning, prosecution strategic planning, various training activities);
- b. commence new activities (the inaugural court rewards program, analysis of opportunities to improve commercial court registries, improving court websites);
- c. host a MDTF-JSS Management Committee meeting; and
- d. supervise the implementation of the MDTF-JSS government-execute d grant and update the results framework.

These purposes were achieved. The MDTF-JSS continues to make progress in supporting the justice sector to strengthen its performance in line with EU benchmarks. Prior to the mission, the Bank had opportunity to meet with you and to discuss the reform agenda and ways in which the MDTF-JSS can support it. The grant component of the MDTF-JSS has been increased to 4.7 million USD, and the project implementation unit is preparing the rollout of new activities. Of note, the Bank and the Supreme Court of Cassation have launched an inaugural rewards program to incentivise performance in first instance courts. Implementation Support Mission AIDE MEMOIRE

September 16 to 30, 2016

- 1. A World Bank implementation support mission for the MDTF-JSS visited Serbia from 16 to 30 September 2016.¹ The objectives of the mission were to:
 - a. monitor the implementation of ongoing activities (analyses of non-core functions in the judiciary, victims support, prosecution budget planning, prosecution strategic planning, various training activities);
 - b. kick start new activities (the inaugural court rewards program, analysis of opportunities to improve commercial court registries and improving court websites);
 - c. host a Management Committee meeting;
 - d. supervise the implementation of the MDTF-JSS government-executed grant and update the results framework.

The team thanks the stakeholders we met during the mission for their generosity of contribution and active leadership. A list of persons met is at **Annex 1**.

KEY FINDINGS AND AGREED NEXT STEPS

2. The MDTF-JSS continues to make progress in supporting the justice sector to strengthen its performance in line with EU benchmarks. Prior to the mission, the Bank team met with the new Minister of Justice, H.E. Ms. Nela Kuburović, to discuss the reform agenda and ways in which the MDTF-JSS can support it. A Management Committee meeting was held on Tuesday 20 September, 2016. Minutes of the meeting are at Annex 2. The grant component of the MDTF-JSS has been increased to 4.7 million USD, and the project implementation unit is preparing the rollout of new activities. The MDTF-JSS website http://mdtfjss.org.rs/en has been updated with information about project activities, reporting and results.

3. At the conclusion of the mission, the following Action Plan was agreed.

UPDATE ON EXISTING ACTIVITIES

Bank-executed activities

- 4. The Bank is working closely with the Supreme Court of Cassation (SCC) to launch the inaugural Court Rewards Program. The program aims to incentivize first instance courts to improve efficiency and productivity in case processing. The program has been formally endorsed and included in the Court Book of Rules. The initiative puts Serbia at the forefront of innovation among judiciaries in Europe in incentivizing court performance.
- The design of the program has been developed jointly by the SCC, High Judicial Council, the task team and the World Bank Development Economics Group (DEC). This year, the SCC will issue two categories of awards: for the largest improvement in backlog reduction and for the largest improvement in the number of resolved cases per judge. Decisions will be based on objective data from case management systems and have been tested and verified by the SCC and the Bank team. In each category, there will be three winning courts, that will each receive a financial award (1st prize 5,000 EUR; 2st prize 3,000 EUR; 3rd prize 2,000 EUR) that they can choose to spend on either: ICT hardware (including desktop computers, monitors, printers, scanners, servers etc.); office equipment (including desks, chairs, conference tables, shelves, clocks, law books etc.); or materials for the beautification of the court (including paint, plants, signage, or materials for repairs). Winning court presidents will be asked to confer with their team regarding the choice of reward and to choose a prize that will improve the performance in their court. Prizes shall be used for the benefit of the court, and rules have been put in place to prevent prizes being monopolized by individuals or used for personal activities. Trophies and plagues will also be awarded to the winners. The SCC will also issue a number of notable mention certificates in recognition of sound achievements. Prizes will be awarded at a ceremony at the Annual Conference of Judges in October 2016. The Bank is supporting a range of communication and dissemination activities to raise awareness of the program among judges, the media, businesses and the general public.
- 6. The Bank shared the draft analysis on how to develop shared services for non-core functions in court and prosecutor offices with the MOJ, SCC, SPC, and HJC, and the team awaits feedback. The report makes recommendations for sharing services in areas such as ICT, security, HR and finance, in ways that will improve service delivery and save costs. Stakeholders

were requested to provide feedback by mid-October 2016, after which the draft will be updated and shared with the MPALSG and the MOF prior to finalization.

- 7. The Bank has finalized the analysis on establishment of victim support services. The analysis is available here http://www.mdtfjss.org.rs/en/mdtf_activities/2016/-analysis-on-serbia-s-alignment-with-the-eu-directive-2012-29-#.V_bGfEIrLX4. During the mission, the team agreed with stakeholders on next steps for support. The Bank will continue to partner with Victim Support Europe (VSE) to conduct: a mapping of all victim support services currently offered in Serbia; an analysis of police responsibilities; a comparative analysis of Finnish and French models for victims support, given their relevance to Serbia's context; an analysis of funding models, given the importance of fiscal sustainability to the viability of the support system. These activities have been agreed with the EU Delegation to ensure that analytic work lays the foundation for future IPA financing, due to come online in 2018.
- 8. The MDTF-JSS is co-funding with the IFC a series of training and capacity building conferences activities focusing on case law harmonization in commercial cases. Topics have focused predominantly on bankruptcy proceedings, but also on privatization, enforcement, civil rights, and corporate crime. Further trainings are scheduled through 2016 and 2017.
- 9. The Bank team is working with the SCC to improve the quality and transparency of its annual reports. The Judicial Performance Expert and the SCC leadership team are developing a new reporting template that will transform the SCC annual reports from 300+ pages of narrative and complex tables to a 50-page analysis of the judiciary's performance, recent achievements and future plans. The template and reporting arrangements is expected to be finalized during the next mission in mid-October 2016. The Bank expert will also partner through 'twinning' with the new SCC statistician during the next mission.
- 10. The team has worked closely with the incoming State Prosecutorial Council (SPC) on a range of institutional reforms. The team has developed an outline of a 5-year Action Plan for the SPC, based on interviews with the SPC members, as well as management and staff of the Administrative Office. The Report also made recommendations for future directions, possible area of support and next steps. available here - http://www.mdtfjss.org.rs/en/mdtf_activities/2016/the-mdtf-jss-worked-together-with-the-stateprosecutorial-council-spc-to-develop-an-outline-for-the-spc-s-5-year-actionplan#.V_bH3EIrLX4. In October 2016, the team will facilitate a strategic planning workshop with the SPC. The SPC aims to finalize its strategic plan this calendar year. Related to this, the SPC has requested a functional review of the prosecution service, noting that the prosecution did not have sufficient data to be analyzed at the time of the Judicial Functional Review in 2013. During the mission, the team developed an outline for the functional review that will be discussed during the strategic planning workshop. The Bank also delivered technical assistance on prosecution budgeting, as the SPC is expected to develop its budget plan for the next calendar year. The draft budget report will be available in October 2016.
- 11. **The team is working with the SCC to improve court websites**. The team has conducted an analysis of the 95 existing court websites, including their internet presence, financing and development, contents and services, user interface, compatibility, design and identify, content management, hosting and human resource arrangements. The report makes recommendations and

The courts have requested the MDTF-JSS to upgrade the court websites based on a template, and the team is developing specifications for this. It became apparent after the mission that the MOJ may have overlapping plans here, and further consultation is required. A similar process is planned with the prosecution service.

- 12. The Bank team is conducting an analysis of the commercial court registries, including opportunities to improve efficiency and user satisfaction at the registries. During the mission, the Registry Expert visited the commercial registries in Belgrade, Čačak, Pančevo, Kragujevac, Niš and Novi Sad. The draft report will be available shortly and will form the basis of future MDTF-JSS support to commercial registries.
- 13. Following consultations with Bank and IFC staff and stakeholders, the team agreed to conduct an analysis of the extent to which the courts constrain the business climate in Serbia. The analysis will be conducted through 2016 and available in early 2017.
- 14. The Judge's Forum has proposed to partner with the MDTF-JSS to conduct an analysis of old cases of small value, to identify reform opportunities to expedite small claims processing. During the mission, it was agreed that the Forum would examine the relevant procedures for conducting such an analysis, develop a methodology and submit a proposal to the Bank.

Government-executed activities

- 15. The Analysis of Court Fee Waivers has been finalized, and the team delivered a presentation of the report and proposed next steps. - 16. **The Backlog Reduction Plan has been finalized with targets and indicators.** A retreat was convened to support the Backlog Reduction Working Group to consider and finalize the plan. The updated plan is available here http://www.vk.sud.rs/sites/default/files/attachments/Zakljuci%20od%2004-04-16.pdf).
- 17. **The Minister of Justice has approved the draft Free Legal Aid Law.** The draft is currently under consideration of the new Government. The MOJ will continue to keep the team appraised of developments.
- 18. Based on the HJC and SPC training needs analysis and the recommendations of the Judicial Functional Review, the PIU is working with the Judicial Academy to deliver a series of training activities across the sector. Some trainings have been conducted, with more planned through 2016 and 2017. An issue has arisen regarding the procedure for reimbursement of travel costs, and the PIU should resolve this as a matter of priority.
- 19. In addition to these trainings, the MOJ has requested support to rollout proposed amendments to the Law on Protection against Family Violence, which is a high priority for the new Government. The MDTF-JSS agreed to support an awareness campaign and accreditation training for judges. The PIU will work with the MOJ and the Judicial Academy to implement these. Further training and activities may be proposed in 2017.
- 20. The Ministry of Justice has requested support to conduct targeted analyses in areas relating to the Chapter 23 accession process. These include analysis relating to the regime for

personal data protection, efficiency in criminal proceedings, and access to justice for persons with disabilities, along with an awareness campaign for the latter. The MOJ has also requested a sixmonth extension of the RAFU. The Bank is considering these requests.

21. **Progress toward the project's development objective remains satisfactory.** The increased momentum within the sector since the increase in the grant amount is accelerating implementation progress.
