MULTI-DONOR TRUST FUND FOR JUSTICE SECTOR SUPPORT PROJECT IN SERBIA (MDTF-JSS)

Implementation Support Mission *AIDE MEMOIRE*September and October 2017

- 1. The World Bank provided implementation support to the MDTF-JSS through a series of short missions through September and October 2017. The objectives of these mission were to:
 - a. monitor the implementation of ongoing MDTF-JSS activities;
 - b. supervise the rollout of new activities under the Serbia MDTF-JSS grant;
 - c. participate in the Annual Conference of Judges, at the request of the Supreme Court of Cassation;
 - d. host a Management Committee meeting with MDTF-JSS donors and beneficiaries;
 - e. launch and disseminate recent work on victim's support services.
- 2. The team thanks the stakeholders we met during these missions for their contributions and active leadership. A list of persons met is at **Annex 1**.

KEY FINDINGS AND AGREED NEXT STEPS

- 3. The MDTF-JSS continues to make progress in supporting the justice sector to strengthen its performance in line with EU benchmarks. A Management Committee meeting was held on 18 September, 2017. Minutes of the meeting are at Annex 2. The MDTF-JSS website http://mdtfjss.org.rs/en is updated continually with information about project activities, reporting and results.
- 4. **A key item discussed during the Management Committee meeting was the future of the MDTF-JSS, noting its current expiry date is 31 December 2018.** At the meeting, the Ministry of Justice, Supreme Court of Cassation, Republic Prosecutor's Office and the State Prosecutorial Council requested that the MDTF-JSS be extended with additional financing to enable its work to continue, noting the ongoing EU accession process and the need for further support to the development and implementation of the updated Chapter 23 Accession Action Plan. Extensions take approximately six months to process. The meeting agreed to start consultations soon to ensure adequate time to plan and facilitate any extension and additional financing.

- 5. Following the Management Committee meeting, the World Bank received letters to this effect from the Minister of Justice, H.E. Nela Kuburović, and the President of the State Prosecutorial Council and Republic Prosecutor, Zagorka Dolovac, formally requesting extension and additional financing. The exchange of letters is attached.

UPDATE ON ACTIVITIES

Bank-executed activities

- 7. **Support to the establishment of a national victim's support service continues.** Three analyses have been finalized on key aspects of the establishment of such a system:
 - a. Mapping of Existing Victim Support Services in Serbia²
 - b. Ensuring Funding for Victim Support Services³
 - c. Operating Networks for Victim Support Services⁴

- 8. Prior to these missions in September 2017, the MOJ and the MDTF-JSS jointly hosted a conference in Belgrade to launch this work and promote discussion of their findings. The Minister of Justice opened the conference, together with the World Bank Country Manager, Stephen Ndegwa, and the Ambassadors of the UK and the Netherlands. From 25 to 28 October 2017, round tables were organized in Niš, Kragujevac and Novi Sad to present the findings of these reports and discuss recommendations. Participants included judges and judicial assistants of the Appeal Court, Higher Court and Basic Courts, prosecutors at all levels, attorneys, representatives of Police Directorate, Social Work Centre and NGOs.
- 9. **During the roundtables, participants used the maps as a platform for dialogue.** The workshops again confirmed how existing services focus primarily in cities, and on support to victims of domestic violence and human trafficking. Little awareness or work is being done to support other forms of victimization or outside of bigger cities. Some institutions were already aware of the interactive map and had linked the map to their website's main page. Judges and prosecutors (assistants) working in information services were interested in additional trainings and increasing of their capacities to communicate with victims.
- 10. Participants were interested in findings and options for funding of victim support system, as this was the first opportunity most stakeholders have had to discuss this issue. The discussion was dynamic and there was a consensus that funding for victim services in Serbia could come from the opportunity cases or the state lottery. There appears to be a need to support the judiciary, as well as government institutions such as police and centers for social work, in their efforts to support victims through their sensitization and referral systems. The CSO sector will need support to expand and strengthen their services. One of the greater challenges for the CSO sector is financial stability and sustainability, given their reliance on some ad hoc project-based funding. The MDTF-JSS is discussing next steps with its implementation partner, Victims Support Europe, to continue support the establishment of victim's support services, together with the OSCE and EU Delegation.
- 11. The main conclusions from the roundtables were that a future victims' support strategy should build on, and improve, the current system of victim support services. The workshops highlighted the need to build the capacities of service providers and the standardization of their work. Sources of funding should also be investigated further.
- 12. The Bank is working closely with the HJC on a training needs analysis and updated training plan for their staff. The current training plan will expire in December 2017, so a review of the implementation of that plan and future needs is necessary. Other donors are not providing assistance in this area. The review applies a similar methodology to the training needs analysis conducted by the MDTF-JSS together with the SPC in 2016, which has formed the basis of their programming. The analysis and updated plan should be finalized in November 2017.

- 13. The Guide to Self-Representation for Citizens and Businesses has been finalized, together with CSO partner, YUCOM. The Bank agreed with YUCOM to fund the next tranche of activities to disseminate the guide through a national awareness campaign. The dissemination phase should start by December 2017.
- 14. The MDTF-JSS supported the Annual Conference of Judges, held at Vrnjačka Banja from October 4 to 6, 2017. Dr. Linn Hammergren presented on a panel discussing Case Weighting Studies.
- Program. The program aims to incentivize first instance courts to improve efficiency and productivity in case processing. The program has been formally endorsed and included in the Court Book of Rules and has been received well within the judiciary as a tool to promote positive competition. The initiative puts Serbia at the forefront of innovation among judiciaries in Europe in incentivizing court performance. Prior to the conference, the Bank together with the SCC assessed the performance of courts and chose the winners based on objective data. In this second year, the number of award categories remained the same but the number of award recipients increased. Also, for the first time this year, the SCC introduced mention rewards for courts that introduced innovations to their work. At the annual conference, the second round of Court Rewards was issued and received national media attention.

Government-executed activities

- 16. **Efforts to improve online transparency of the work of prosecutors continue.** Minor improvements are being made to the recently upgraded website of the SPC. Recent data shows that traffic to the SPC website has increased significantly and that a large number of documents are being viewed and downloaded. The PIU has contracted a firm to design and upgrade all websites in the prosecution network. Work should commence in December 2017.
- 17. The Bank is supporting the HJC and SPC to develop an integrated human resource management information system and a budget preparation and monitoring information system. Bank staff together with PIU staff and representatives of the HJC and SPC are canvassing options and developing a TOR. The PIU will start the procurement process in early 2018.
- 18. The SCC developed and launched its Semi-Annual Report on Work of All Courts.⁸ The report was based on the model developed in 2016 together with the MDTF-JSS. During the mission, the MDTF-JSS agreed to fund translation and printing of the report to further highlight the SCC's good results over the period.

- 19. The SCC designed its Backlog Case Management training program for Basic Court judges which will be delivered in collaboration with the Judicial Academy. The first two rounds of training will be delivered towards the end of 2017.
- 20. The SCC facilitated five round tables in four appellate areas on challenges in implementation of the new Law on Enforcement and Security (LoE). Roundtables brought together judges from Commercial, Higher and Basic Court and public enforcement agents to discuss open legal issues and collect, systematize and compare the relevant ECHR case-law. These various workshops have been supported jointly between the MDTF-JSS, the EU-financed Judicial Efficiency Project and USAID. The SCC plans to convene a conference on this topic in November 2017, supported by the Council of Europe. The Bank has been invited to the conference to present its recent regional report, *Towards Effective Enforcement of Uncontested Claims: Lessons from the EU 11* (not funded by the MDTF-JSS but by the World Bank and the Ministry of Foreign Affairs of the Netherlands.)
- 21. The MDTF-JSS continues to support the SCC's efforts to harmonize case law. Seven joint meetings were held with the four appellate courts and three with higher courts, with the SCC justices. Four additional meetings of appellate and higher courts with the Supreme Court justices are planned for December 2017, and these will focus on disputed legal issues in civil and criminal cases. A further focus group meeting is also planned on 23-24 December 2017 focusing on trial within reasonable time standards, CEPEJ standards and ECHR standards. These various workshops have been supported jointly between the MDTF-JSS, the Judicial Efficiency Project and the Council of Europe. The fourth conference on case-law harmonization for judicial advisers and assistants of the SCC, state-level courts, appellate courts and higher courts, will be held in December 2017, and will focus on the 'triangle of jurisdictions' between Strasbourg, Luxembourg and national courts. This will also be supported jointly with the Council of Europe.
- 22. The PIU is preparing to scale up sector-wide trainings for judges and staff working across the justice sector. Future offerings will include training on case management systems and certification courses in various IT-related subjects (ECDL base, Microsoft Word. Administering Windows Server 2012, Querying Microsoft SQL Server); Course in Data Mining Exploratory analysis. Training for communication skills, public relations, project management, financial management and human resource management are also being scaled up. Targeted trainings are also being developed on legal terminology and legal topics such as Non Bis In Idem and CEPEJ reporting.
- 23. The MOJ requested interest in fast-tracking small claims procedures, as part of its broader efforts to update the civil procedure code. The Bank agreed to provide targeted technical assistance to further explore options for fast-tracking, including by analyzing how many small claims there are in Basic Courts in Serbia, which are the best comparator countries for Serbia, which practices work best for them, relevant legal provisions relating to small claims, and how those countries navigated the reform process. A short mission focused on this activity will be conducted in November 2017.
- 24. **Progress toward the project's development objective remains satisfactory.** The latest World Bank Implementation Status and Results Report is available here,

The rating for implementation progress was upgraded from Satisfactory to Highly Satisfactory, noting the recent improvements in PIU performance, reflected in the increased grant amount, increased pace of activity implementation, increased rate of disbursements, and progress against the results framework.

2. MDTF-JSS management and administration

a. Bank task team arrangements

The Bank advised that Ms. Harley will take maternity leave in early 2018, and that Mr. Svircev will continue as task team leader through the period.

As agreed during the last Management Committee meeting, future meetings may also be facilitated via video-conference to accommodate the increasing interest in participation among stakeholders, and among Bank staff in Washington DC.

b. Reporting

The Bank agreed to translate the most recent progress reports of the MDTF-JSS from English to Serbian, as requested by the President of the Supreme Court of Cassation.

As agreed during the last Management Committee meeting, the Bank offered to push MDTF-JSS website updates via email to the MDTF Management Committee distribution list to increase convenience for donors and visibility of MDTF activities. The first such period email update, in the form of a newsletter, was shared in July 2017. Feedback on this format is welcome. All outputs will also continue to be available on the MDTF-JSS website.

c. MDTF-JSS expiration in December 2018

The Bank noted that the MDTF-JSS is due to expire in December 2018. This would mean that MDTF-JSS implementation would taper off from the Summer of 2018, to give adequate time for the project to finalize activities and close out its reporting.

The MOJ, SCC and SPC requested that the MDTF-JSS be extended with additional financing to enable its work to continue, noting the ongoing EU accession process and the need for further support to the development and implementation of the updated Chapter 23 Accession Action Plan. The Bank advised that extensions take approximately 6 months to process. The meeting agreed to start discussions soon regarding the future of the MDTF-JSS to ensure adequate time to plan and facilitate extension and additional financing.

3. Update & discussion of recent progress

a. Bank executed advisory services:

b. Government-executed implementation:
